External Data Validator is the tool which can help to polish the data from setup until close out making it a perfect example for 100% programmed reconciliation

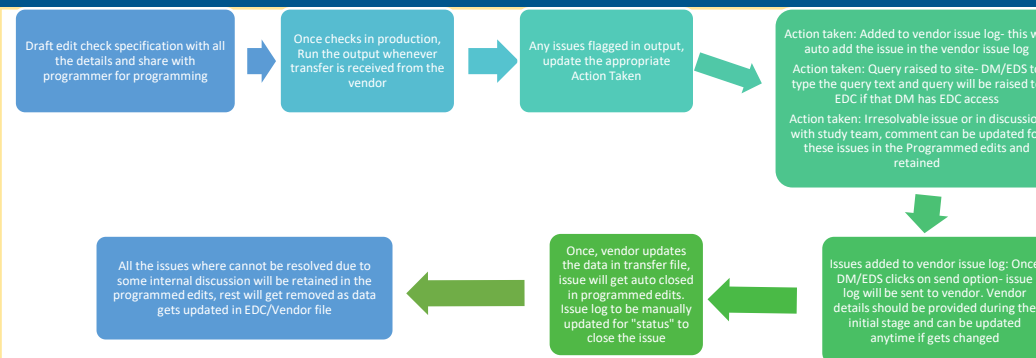
AIM
